## The Executive Committee - History and Mandate

The EC exists since 2008 to ensure continued guidance in between Board Meetings:

- Review of progress on Workplan implementation
- Appropriate action and recommendations to the Board on key issues
- Guidance to the Secretariat on activities (between Board Meetings)
- Oversee and track resource mobilization
- Advise the Board on core governance structures
- Make decisions on reactive opportunities, even when outside the Workplan

  - Ensure consultative process and oversee feedback, consult constituencies through EC members
  - Selection of SO coordinators
- Feedback on development of a new constituency for the private sector, due diligence and applications feedback
- Feedback on elections for new ART representatives
- Consultations on the membership of the Task Team for Financing for RMNCH

  - Documents prepared for the face to face Donors & Foundations constituency meeting on 3 February in London
  - Feedback on "private sector engagement guide"
  - Feedback on RfPs and other work
  - On-going feedback on the PMNCH task team on Financing Report, guidance on next steps
  - Feedback on preparations/agenda for the Board Meeting

   ensure the EC member has had time to consult with constituency to bring constituencies' views and not their own
