OBJECTIVES

The 31st PMNCH Board meeting focused on four strategic opportunities for country-led action, supported by PMNCH constituencies:

- Engaging with the **G20 and G7** platforms to strengthen leadership and policy action for women, children and adolescents;
- **Financing and policy opportunities to address the impact of climate change** on women's, children's and adolescents' (WCA) health and well-being;
- Leveraging the **Global Forum for Adolescents** on 11-12 October 2023 to increase commitment to adolescent well-being, and to raise visibility for the needs and priorities of young people themselves through the **1.8 campaign**; and
- Strengthening **partner alignment at country level** to drive implementation of commitments, including through high-level leadership and bottom-up community action.

PMNCH Board Vice-Chair Rajesh Bhushan, Secretary, Ministry of Health and Family Welfare, provided his reflections as part of his welcome message.

ITEM 3a – The G20 and Women's, Children's and Adolescents' Health: One Earth, One Family, One Future

This first Strategic Dialogue was set against the backdrop of the upcoming 18th G20 Heads of State and Government Summit, to be held on 9-10 September 2023 in New Delhi, India.

This session focused on identifying ways in which PMNCH can best support the G20 India presidency and G20 members in ensuring appropriate recognition and support for the urgent needs of women, children and adolescents within the main negotiation tracks of the G20 summit in 2023. It also considered how to strengthen the position of these issues ahead of the G20 summit in Brazil in 2024.

To inform G20 member-states about current needs and opportunities for health and well-being of women, children and adolescents (WCA), PMNCH was invited by [ThinkTwenty \(T20\)](#)¹ to develop a policy brief on the current status, trends, needs, and priorities to improve the health of women, children and adolescents in G20 countries.

Anshu Banerjee (WHO, UN Agencies Constituency) provided a brief overview on the G20 Policy Brief. Following this, the Deputy Minister of Health of the Republic of South Africa, Dr Dhlomo (Republic of South Africa, Partner Governments Constituency), and María Antonieta Alcalde (IPAS Latin America and the Caribbean, Non-Governmental Organizations Constituency) provided reflections in response to the presentation.

The Board had the opportunity to hear from the Indian G20 Sherpa, Amitabh Kant, who spoke passionately of India's concern with addressing the underlying drivers of well-being for women, children and adolescents through the G20 presidency this year, including the necessity to address the economic empowerment of women to reduce gender disparity and improve health and nutritional status. Mr Kant urged PMNCH members to be 'radical' and 'visionary' in advocating for women's empowerment and the improved economic well-being of WCA as a lever of sustainable development (*'Put women at the centre of growth and promote them as leaders'*).

The item ended with remarks by Shombi Sharp, UN Resident Coordinator for India.

The discussions centred around the following themes:

- PMNCH's G20 advocacy efforts should be ambitious and should consider the broader structural drivers of health and well-being, including economic growth and stability.
- Empowering women and ensuring an equitable distribution of societal wealth to women is one of the key levers that could be applied to drive WCA health and well-being related progress.

¹ The T20 is an official group of the G20, which serves as an 'idea bank' by bringing together think tanks and high-level experts across the world to discuss policy issues relevant to the G20, over and above the issues being discussed in the formal tracks of the G20 process. As part of this process, the T20 will offer policy recommendations to the G20 leaders ahead of the Leaders' Summit in September 2023 to help the G20 deliver concrete policy measures.

- The many crises facing WCA health and well-being are also opportunities for building new and stronger partnerships. This is the right time to focus political attention on health and well-being: The COVID-19 pandemic has brought the impact of health on world economies into a much sharper focus than has ever before.

ITEM 3b – The G7 and Women's, Children's and Adolescents' Health

Strategic Dialogue 3B builds on the history of PMNCH's successful engagement with G7 member states in advocating for increased financing and policy measures for WCA health and well-being.

This Strategic Dialogue focused on exploring how PMNCH can develop a multi-year influencing approach for the G7, with the aim of maximizing support for SRHR, as well as MNCH and AWB. The participants also considered how the recent G7 support (i.e., at Hiroshima in 2023) for SRHR in UHC can be leveraged to increase visibility for SRHR, MNCH and AWB issues within the outcomes of the UN High Level Meeting on UHC in September 2023 in New York.

Two presentations opened this item. The first of these was by Chris Carter (PMNCH Board Vice-Chair; UK, Donors and Foundations Constituency), giving a 'first-hand' account of UK member-state perspective on what the 2023 Japan G7 has delivered for health and gender, and opportunities for further progress to be made in the years to come, with the support of all PMNCH stakeholders. Following, Ann Starrs (PMNCH Co-Chair of SAC; BMGF) presented the outcomes from the Hiroshima Summit in 2023, as well as a draft advocacy roadmap for PMNCH in 2024 and 2025, including possible events, products, champions and media opportunities where PMNCH can play an influencing role.

The discussions centred around the following themes:

- The Board congratulated all members involved in the G7 advocacy processes to date, noting significant SRHR-supportive language that was included in the G7 statements (from leaders as well as ministers).
- PMNCH has demonstrated its unique position to influence G7 processes. Future advocacy efforts should continue to be directed towards this important global forum, with a long-term plan that engages G7 processes early on and across its varied elements (i.e., leaders' communique, health communique, technical groups, etc.), in an organized and cross-constituency manner.

- Advocacy approaches need to be reflective of and adapted to priorities of different G7 presidencies, while working with all G7 nations to prioritize WCA health and well-being within the available frameworks for each G7 summit.
- Throughout PMNCH's advocacy work, it will be important to ensure clarity and consistency across all communication and actions that PMNCH advocates for all three strategic goals: MNCH (maternal, newborn and child health), SRHR (sexual and reproductive health and rights) and Adolescent Well-Being. However, PMNCH may focus in on one or more of these components, depending on the context and therefore advocacy opportunities, as may be relevant.

ITEM 4 – Addressing the impact of climate change on WCAH: Emerging opportunities, including climate financing, for PMNCH action

Under this agenda item, the PMNCH Board reflected on the most recent evidence on the impact of climate change on WCA health and well-being, and discussed how PMNCH can best advocate for solutions to mitigate these effects and adapt to climate change in vulnerable populations, including through increased and targeted financial investments.

Flavia Bustreo (Fondation Botnar, Donors and Foundations Constituency), provided introductory remarks, which were followed by two scene-setting presentations:

- Zulfiqar Bhutta (Aga Khan University and Sick Kids Hospital, Toronto) provided a brief overview of evidence of the impact of climate change on WCAH, and priorities for action; and

- Mark Hanson (Chair, PMNCH Knowledge & Evidence Working Group) presented the current gaps and opportunities in co- or blended financing for improved outcomes for WCAH, based on a review by Jo Borghi and team of the London School for Hygiene and Tropical Medicine.

An open dialogue moderated by Flavia Bustreo and David Imbago (International Youth Health Organization, Adolescents and Youth Constituency) followed these presentations. Panellists included German Velasquez (Green Climate Fund) and Agnes Soucat (Agence Française de Développement, Donors and Foundations Constituency).

The session ended with closing remarks by Juan Pablo Uribe (World Bank, Global Financing Mechanisms Constituency).

The discussions centred around the following themes:

- Discussions contextualized climate change as one of the biggest and most pressing global challenges for the health and well-being of women, children and adolescents.
- Significant investments being channeled into climate mitigation and adaptation need to reflect the importance of WCA health and well-being to public health and prosperity across the life course. In many ways, addressing climate change is 'all about health', especially the impacts on the most vulnerable populations and WCA in particular.
- Climate change and health are becoming national issues and not just issues that are confined to health ministries; PMNCH has an opportunity to support these national as well as global dialogues by advocating for greater financing, supportive policies, and adapted services, while guarding all stakeholders against fragmentation and unhelpful competition.

ITEM 5 – Advancing Adolescent Health and Well-Being through the Global Forum for Adolescents and 1.8b Campaign

During this discussion, the PMNCH Board explored the opportunities to work together and leverage the Global Forum for Adolescents (GFA) on 11-12 October 2023 for mobilizing greater commitments to adolescents' well-being, through the 1.8 Billion Young People for Change global campaign. It also focused on how to engage partners, leaders and champions to ensure comprehensive accelerated progress toward the 2030 Sustainable Development Goals (SDGs) and beyond.

Aditi Sivakumar (Board Vice Chair under-30, Adolescents and Youth Constituency) provided a brief presentation on progress. The presentation took stock of the work PMNCH partners have undertaken to date towards the GFA.

This was followed by oral interventions from each PMNCH constituency representative on actions being taken to advance the goals of the 1.8 campaign and the Global Forum, which are summarized in Annex 2 of this document. Open discussion followed, providing guidance and direction for cross-constituency action to accelerate planning and impact of these activities.

The discussions centred around the following themes:

- The Board noted the many important initiatives that are already underway, noting the need to ensure alignment and leveraging for greater impact. Currently collaboration between PMNCH and other initiatives / mechanisms (e.g., FP2030, ENAP/EPMM, GFF, etc.) are being actively pursued for the benefit of AWB as well as the broader WCAH continuum, with a view that acting together in a more coordinated manner will result in more effective follow up and / or mobilization of new commitments.
- Reflected on the excellent support that all constituencies are providing and committing to in terms of the Global Forum for Adolescents, and associated AWB commitment mobilization processes. This includes the efforts to secure voices of young people themselves - noting

significant progress towards the target of one million young voices collected through the massive “What Young People Want” survey effort.

- Importance of coordination at global, regional and national levels, empowering national stakeholders (including governments) and young leaders themselves to lead the efforts, as well as existing accountability mechanisms (e.g., as led by parliamentarians in countries and through the Inter-Parliamentary Union processes).
- Transparent and inclusive multi-stakeholder platforms are important and powerful mechanisms to take this work forward.

This agenda item provided an update on strategic approaches to advance the implementation of existing country commitments effort, for WCA health and well-being through the development of partner-led Country Advocacy and Accountability Plans (“CAAPs”) in 10 to 13 countries in 2023, and related commitment mobilization efforts for adolescent well-being in 15 countries. It reflected on the work through high-level champions (e.g., Global Leaders Network; parliamentarians), grassroots organizations and processes (e.g., citizen hearings), etc.

Joy Phumaphi (PMNCH Chair of PECC, African Leaders Malaria Alliance) provided an update on status and objectives of this country-focused work.

This was followed by remarks from Olive Shisana (Special Advisor on Social Policy to the President of South Africa), Julitta Onabanjo (UNFPA, UN Agencies Constituency), and Per Falk (Ferring Pharmaceuticals, Private Sector Constituency). A discussion ensued, moderated by Githinji Gitahi (PMNCH Co-Chair of SAC, AMREF Health Africa).

The discussions centred around the following themes:

- National governments make WCAH commitments in response to existing global, regional and national obligations. These commitments are influenced by the changing socio-economic environments, humanitarian contexts, as well as resources available to government and other local actors.
- High-level political leadership and advocacy is necessary to drive strategic policy shifts, ensure stakeholder alignment, and support multi-sectoral commitments and actions to safeguard WCAH issues in the context of poly-crises.
- Successful implementation of commitments requires all partners to support the leadership of national governments through provision of technical, financial and service delivery support. In this regard, in-country coordination among partners must be strengthened using tools such as the Digital Advocacy Hubs (DAHs) and the PMNCH Partner Zone, as well as the efforts of the PMNCH Secretariat.
- Ongoing monitoring of commitment implementation through open, inclusive and solutions-oriented accountability approaches is critical. It is important to learn from existing global, regional and national frameworks and mechanisms to better align with and leverage existing mechanisms, including aligning with the facilitation and support from UNA and CSO constituencies, each playing their unique role.
- Capacity building, consensus building, and cross-sharing are also important to facilitating active engagement by partners, especially local civil society organizations. In this regard, knowledge resources such as the digital commitments compendium, and those generated by UN agencies and other partners (GFF, FP2030, etc.) as well as academic, research and training institutes, should be made easily accessible through the DAHs, linking with existing knowledge platforms.

We have one of the grantees here -- and if members are curious about the process of mobilization - please do reach out to the YP Foundation to understand how they are working with young people on the ground to mobilize responses in the country. This work is also closely related to the commitment mobilization work where the grantees are working with lead partners.</i> <i>As a part of their effort to support the campaign, all the grantees will organize a national event in the months to come in support of the forum and support commitment mobilization through national advocacy roadmaps which they have developed in support of the Forum.</i> <i>In addition to the grantees, other youth networks of the AYC have also been keen on organizing national events. The AYC has been instrumental in tapping the student community for this. Students from One Young World at the University of Bath organized an event in UK in April, while a youth led organization organized an event in China recently. 	<i>of young people and why political and governmental commitment is key to making it happen. The discussion had underscored the need to educate across the life course, but much more remained to be done and further considered. We are currently looking into ways to give these issues more visibility at the upcoming IPU Assemblies. The IPU Advisory Group on Health (AGH), of which PMNCH is a technical partner, will also be consulted and could support addressing adolescent wellbeing. The AGH supports the implementation of the health component of the IPU Strategy by focusing on inequalities and discrimination that stand in the way of universal access to services. One of the main areas of work of the AGH is women's, children's and adolescents' health and well-being.</i> <i>As the AWB monitoring framework is currently being developed, we encourage linking it to ALMA's tools including the community scorecard. Making parliamentarians aware of this resource is equally important especially as it relates to their own country's accountability mechanisms will be critical.</i> <i>For the Global Forum for Adolescents (GFA), ALMA's Youth Advisory Council have submitted an expression of interest to lead and contribute to the 5 core programmatic tracks, and side-events of the Global Forum for Adolescents. The efforts of the National Youth Armies supported by ALMA (both in Africa and diaspora) could be very helpful in disseminating the chatbot link to the already engaged 3.5k African youth and their networks and soliciting their input on matters of importance to them – The chatbot link has been shared with ALMA's malaria youth champions via the telegram group which has 1000 members. ALMA's National Youth Armies could also strategically leveraged to organize innovative national events.</i> <i>Young parliamentarians could be encouraged to gather the voices of young people through their functions of constituency outreach. However, I need to point out here that the cut-off point for young MPs in IPU is 45 years of age and not 30. The IPU will promote the GFA through our social medial channels and will undertake future joint collaboration with PMNCH similar to the collaborative posting on Instagram across both the 1.8 Billion Campaign and the IPU channels during the 146th IPU Assembly in Manama which led to increased engagement of the 1.8 Billion campaign.</i> <i>We are in constant contact with PMNCH and stand ready to mobilize parliamentarians as well as the IGO constituency around the GFA, as appropriate. PMNCH NGO Constituency members have been actively involved in the strategizing and planning of the Global Forum – including representation in the dedicated Global Coordination Committee, the Programme Action Group, the Partnership and Communications Action Group and the Digital Experience Action Group.</i> <i>In terms of the programme creation for the Global Forum, we are very pleased to share that the NGO Constituency members responded overwhelmingly to the Expression of Interest for organizing concurrent sessions during the Global Forum's main programme in October. I am very excited to share that over 70% of the submissions made were by NGO constituency members who are continuing to demonstrate their commitment for the adolescent well-being agenda.</i> <i>Furthermore, NGO constituency members are also taking the agenda to the communities by organizing various national events in support of the Global Forum across different regions. To-date nearly 51+ events have been registered across nearly 30 countries. I am pleased to share that over half of the events organized are by NGO constituency members championing and spotlighting a spectrum of issues impacting adolescent well-being including SRHR, mental health, climate change, nutrition, empowerment, education, and</i>

	<i>meaningful engagement. NGO members, both in high-income countries and low- and middle-income countries alike are leading this by organizing localized events in support of the Global Forum. For example, NGO partners in the UK - collectively organized a dialogue with Parliamentarians in the House of Lords in May 2023. In the coming months, we hope to have more of our membership organize more events in support of the Forum.</i> <i>As you have already heard, Plan International, is a part of the NGO Constituency Leadership and is coordinating the mobilizations of commitments for Adolescent well-being in 7 countries. We have also sensitized the PMNCH partners and NGO constituency members in the commitment countries to ensure the commitments being drafted are in response to the lived experiences and the community demands emerging from the voices gathered through the What Young People Want Initiative.</i> <i>NGO members have also been critical in leading engagements, including Africa Health Agenda International Conference (AHAIC) in March 2023, the ECOSOC Youth Forum in April 2023, the 76th World Health Assembly (WHA) in May 2023, and other events throughout the year and on the road to the Global Forum in October 2023. Going forward, we hope to document some of the learnings in terms of our engagement with the 1.8 Campaign and the Global Forum and inspire more of the membership to collectively deliver for the Forum.</i>

We are a part of the Global Coordination Committee for GFA.</i> <i>As part of our contribution, the Ministry organized the MoHFW G20 co-branded event, which was preceded by the 4 youth focused regional consultations spread across India to ensure representation, and, 1 global consultation in partnership with PMNCH to gather perspectives and opinions of what young people want.</i> <i>These 5 consultations have informed language in the outcome document of the MoHFW co-branded G20 event as well as the thematic paper, both of which were released by the Hon'ble Ministers of Health, Govt of India, during the event held on the 20th of June here in New Delhi.</i> <i>As committed by Govt of India, we will continue to support all of PMNCH's efforts to advance adolescent well-being and more broadly women, children and adolescents health and well-being.</i> <i>We will build upon the success of this event and continue to consult adolescents and young people to formulate policies and programs that have a bearing on their health and well-being.</i>

	<i>The PS constituency acknowledges the imperative of a dynamic conversation on how decisive government policies and leadership within the private sector can mutually enhance and foster ambition for adolescent health and well-being. This dialogue will help portray the private sector as a part of the solution in policy discussions within the G7, G20, and COP28 contexts.</i> <i>We are delighted to share the increasing local initiatives, both led by or involving the active participation of the private sector, rallying behind the 1.8 billion campaign and empowering young people as agents of change. For example, Rotary and Rotaract hosted a successful youth-driven event in Australia, the Big Pink. In Ghana, in partnership with Datalog Research Lab, we are fostering academic discussions and multi-stakeholder forums to deliberate on critical issues regarding adolescent health. In Nigeria, DAI Global is enhancing adolescent reproductive health and empowering this segment with the skills, social capital, and resources needed to realize their full potential through various interventions and youth-led events.</i> <i>Lastly, we are ensuring that the private sector is aptly represented in the virtual Global Forum for Adolescents sessions, highlighting our commitment to youth health and well-being where it truly matters.</i>

These accomplishments are a testament to our ongoing efforts to effect positive change and create a better future for adolescents globally.</i> <i>The Technical Working Group, comprising members from the H6 agencies, UNESCO, and PMNCH, developed the Adolescent Health and Wellbeing Framework. A timebound expert consultative group has been established to support the development of the Adolescent Health and Wellbeing monitoring framework which will be presented at the GFA. Furthermore, the UN agencies have made substantial contributions to the BMJ collection, showcasing our dedication to knowledge dissemination and evidence-based practices. Additionally, we are updating the Accelerated Action for Health for Adolescents Framework, a comprehensive compilation that incorporates WHO recommendations spanning a broad spectrum of adolescent health areas. These encompass vital aspects such as physical activity, nutrition, sexual and reproductive health, mental health, and emerging lessons from the unprecedented challenges posed by the COVID-19 pandemic. By enriching the content of this update, we ensure its relevance and applicability to the evolving needs of adolescents worldwide.</i> <i>With regard to the forthcoming Global Forum for Adolescents, we affirm our commitment to robust engagement with stakeholders. In this regard, UNICEF and UNFPA are actively convening the program action group and WHO is represented in the Global Coordination Committee.</i> <i>In November last year, WHO communicated with the country offices, highlighting the Global Forum of Adolescents and urging them to support efforts in making youth and adolescents visible in reporting to the SDG Summit. UNICEF and UNFPA sent a similar joint letter earlier this year. We acknowledge that data disaggregation at the country level can present challenges; however, we have encouraged our offices to collaborate closely with governments to address this issue and emphasize the importance of comprehensive reporting.</i> <i>At the regional level, our agencies have engaged with various working groups and committees. Notably, UNFPA has actively engage its regional adolescent and Youth advisors and key country office colleagues, while UNICEF has concentrated its efforts on the Caribbean and Mediterranean regions. Furthermore, we are pleased to note that the WHO Regional Committee for the Eastern Mediterranean region is planning a side event, which will be prominently showcased during the plenary session of the Global Forum for</i>

Adolescents. Significantly, our collective efforts extend to supporting the submissions that have been made. UNFPA has spearheaded this initiative with five submissions, and we have further collaborated with external organizations for an additional 23 submissions. UNICEF has supported numerous partners with their submissions. WHO has also submitted for the Global Forum, focusing on the implementation of the Adolescent Health and Wellbeing Framework and the Monitoring Framework. These collective endeavors address critical issues such as gender-based violence, sexual reproductive health, comprehensive sexuality education, and more. We remain fully engaged in supporting our partners to enhance the quality of submissions and provide necessary assistance in their preparation for the forum.

Recognizing the paramount significance of engaging young people, we have initiated discussions with UNESCO to foster collaboration with Ministries of Education to encourage schools to facilitate dedicated 60-90 minutes sessions on the 11th or 12th of October, enabling students to discuss their health and well-being openly. UNESCO has experience in the past supporting similar activities and we are awaiting the result of their internal discussion. In order to reach more young people WHO has thought the global youth mobilization an existing collaboration with the 6 Big Youth organizations who collectively have a membership of around 250 million people. Both UNFPA and UNICEF are mobilizing their respective youth networks. WHO has launched a Youth Council to enable young people to engage with WHO and influence its work. The constituency also proposes to organize briefings in advance of 11 and 12 October in Geneva and New York for Permanent Missions, bilateral partners, GHIs, civil society and parliamentarians in order to ensure there is a global component recognizing the need to for global partners to be involved and are willing to see how if of value they can be linked to the actual GFA.

The UNA Constituency will use its social media to amplify the PMNCH Social Media Toolkit. The UNA Constituency looks forward to working with PMNCH through 2023 in the lead up to the Global Forum for Adolescents and to continuing engagement with the 1.8 Billion Young People for Change Initiative.
