

Foreword

As we round the corner towards the final five years of the 2030 Sustainable Development Goals (SDGs) era, PMNCH can look back with pride on many important advocacy accomplishments achieved during our 2021-2025 strategy period. Just a few years ago, "meaningful adolescent and youth engagement" (MAYE) was a slogan and an ambition, but 2023's Global Forum for Adolescents (GFA) and the 1.8 Billion Young People for Change campaign turned that into action, showing how much can be achieved when young people lead our work.

Similarly, the voices of women and families took centre stage in the Born Too Soon report on preterm birth, which launched in 2023. Their experiences and demands—for access to quality care, equity and dignity— underline why PMNCH will never stop fighting for better primary care systems through universal health coverage. Protecting the rights of every woman and every child everywhere is our mission and our pathway to a more sustainable and just world for us all.

Yet, as we head into 2024, times are tough. We have lost momentum on reducing maternal, newborn and child mortality; the anti-rights movement around sexual and reproductive health and rights (SRHR) has gained ground; and our youth and adolescents, the future leaders of our world, are burdened with profound challenges to their well-being, including their mental health. Women, stillborns, newborns and children under-five had larger survival gains from 2000-2015 compared to 2016-2022.

Urgent actions are therefore needed globally to accelerate progress and reduce unacceptably high levels of maternal, newborn and child deaths. As PMNCH partners, you know these issues all too well.

As the newly appointed Executive Director of PMNCH, I'm struck by our "superpower" as an incredibly active and growing platform made up of almost 1 500 organizations from 127 countries and 10 constituencies. Since 2020, the number of members has increased by nearly 40%, and membership applications increased by 50% in 2023 alone. Our unique ability to drive home coordinated, evidence-based messages for sexual and reproductive health and rights (SRHR), maternal, newborn and child health (MNCH) and adolescent well-being (AWB)— from high-level champions down to grassroots partners—is a massive force for good. Yes times are tough, but we stand ready.

This annual report showcases just some of PMNCH's incredible impact in 2023. I look forward to more progress in the months and years ahead.

Where you live should never determine whether you live. Where you were born should never dictate your value. Wealth should never govern your health. We can all agree on those principles, and recognize that healthy and empowered women, children and adolescents are the cornerstone of stronger communities, vibrant economies and resilient societies.

Yet, millions of women, children and adolescents continue to die from preventable, treatable causes, while many more are threatened by the ongoing polycrisis of conflict, climate change, economic downturns and volatility.

The Partnership for Maternal, Newborn and Child Health (PMNCH) brings together nearly 1 500 stakeholders and organizations for high-level advocacy in three main areas: MNCH, including stillbirths; SRHR; and AWB.

Young people and adolescents were at the forefront of PMNCH's work last year, as they led the charge for more action and commitments from their governments. During our 1.8 Billion Young People for Change campaign, we listened to the voices of 1.5 million young people expressing what they most want for their well-being. This informed the very first Agenda for Action for Adolescents and resulted in 36 commitments from governments, regional bodies and philanthropic and other organizations that now provide a roadmap for increased financing and improved policies and programs for AWB. I know from long experience that deep and lasting change, doesn't happen unless we really listen to the voices of those who most want and need that change – and that means the young leaders of today who have the biggest stake in tomorrow.

Our focus on MNCH will continue for as long as deep inequities persist between and within countries. We must ensure that every woman has access to high-quality reproductive and maternal care, and that every baby born prematurely can thrive. Our report on prematurity and integrated maternal and newborn care (Born too soon; decade of action on preterm birth), published in May 2023 together with more than 70 partners from 46 countries, sets an ambitious agenda to address the causes of preterm birth, reduce the burden and advocate for high-quality care so that women and babies can survive and thrive, wherever they are.

SRHR will always be a key priority for PMNCH. Yet, we live in a challenging time of regressive policies and a surge in gender-based violence, child marriages and unwanted pregnancies. PMNCH is fighting back, promoting gender-responsive action and protecting

progressive rights to sexual and reproductive health. With our support, multi-stakeholder partnerships within communities, and across sectors, are building momentum for equality.

Looking forward, we will increase our efforts to influence global, regional and national priorities. The Global Leaders Network, which we initiated in the past year, advances policies, programmes and financing initiatives. As well as acting within their own countries, network members influence regional and global platforms. With the South African President, His Excellency Cyril Ramaphosa, as Chair, the network is to include leaders from other regions, and tackle challenges such as pandemic preparedness, climate change, SRHR, conflict and food insecurity.

These challenges, combined with recent, tragic events, not least in Ukraine and Gaza, vividly demonstrate the world's vulnerability, and show that the work of PMNCH is needed. Working together, we can change the world for the better.

Thank you to all our partners for your commitment. Thank you for maintaining the pressure for change. Thank you for working to improve and save lives.

PMNCH enables members to deliver more collectively than each could deliver alone, across three thematic areas of work:

- MNCH: preventable maternal and child mortality, including newborn deaths and stillbirths, with a focus on humanitarian and fragile settings;
- SRHR: advancing progressive SRHR and countering the growing pushback on SRHR; and
- AWB: advancing the well-being of adolescents.

With advocacy as its core functionsupported by knowledge synthesis, partner engagement, campaigns and outreach-PMNCH seeks changes in policy, financing and services for women, children and adolescents, and holds each other accountable for delivering on promises.

2. 2023 highlights

2.1 Adolescent well-being (AWB)



The Global Forum for Adolescents (GFA) was held from 11-12 October 2023 as the world's largest online gathering for adolescent well-being (AWB) in response to the current

situation which sees more young people (aged 10-24) than at any other time in world history. Many of those are not reaching their full potential due to the failure of current policies and a lack of investments to meet their needs. The GFA brought together a global community of adolescents, advocates and leaders for two impactful days of debate, dialogue and action.


The Forum took place within the context of the 1.8 Billion Young People for Change campaign, a bold global movement asking young people what they want for their health and well-being and building demand for decision makers to transform their answers into policies, investments and actions from world leaders.

The response was overwhelming; more than 1.5 million young people from more than 90 countries shared their needs, desires and dreams through the What Young People Want platform, which informed the Agenda for Action for Adolescents.

The Agenda highlights seven priorities for urgent action and a path forward for governments, in partnership with stakeholders from all sectors, to develop and implement policies and programmes that deliver on these priorities. It advances the adolescent agenda within the current Sustainable Development Goals (SDGs) and sets the scene for the post-2030 global development agenda, co-developed with and owned by adolescents and youth.

Partners supported the campaign by hosting 126 national events in 50 countries dedicated to advocating for improved adolescent and youth health outcomes. Eight knowledge products were launched at the GFA to expand the evidence-based work on adolescent well-being, and

commitments for adolescent well-being were mobilized from 18 Member States, two regional bodies (the African Union and European Union), 13 philanthropic and other funding organizations, and three non-state actors including non-governmental organizations, inter-governmental organizations and health-care professional associations.




2.2 Maternal, newborn and child health (MNCH)

Born too soon: decade of action on preterm birth

PMNCH led the work on the updated edition of the Born too soon report on preterm birth, aligning with Every Newborn Action Plan-Ending Preventable Maternal Mortality (ENAP-EPMM) targets, and involving to date more than 70 partners across all PMNCH constituencies. The report calls for systemic change to ensure that every woman and baby receives high-quality, respectful care to thrive, regardless of geographic location. It also includes a series of country snapshots to highlight key learnings and successes from around the world.

The report was launched in May 2023 at the International Maternal Newborn Health Conference (IMNHC) in Cape Town, South Africa with testimonials of community members who attended the conference. More than 1 700 stakeholders from around the world were in attendance to accelerate solutions to improve maternal and newborn survival and prevent stillbirths. An MNCH messaging brief was produced by PMNCH for the conference and launch of the report.



The report has the highest reach of any PMNCH knowledge product. * 1.3 million people were reached in social media, and media coverage generated an estimated potential reach of nearly 3.5 billion with 215 media hits across the world.

High-level champion-led media op-eds

Two high-level champion media op-eds, released by PMNCH, were instrumental in raising awareness of this dire situation: Millions of women are still at risk of dying during pregnancy and childbirth in The Telegraph by Rt Hon. Helen Clark and Dr Adhanom Ghebreyesus Tedros, Director-General of the World Health Organization in April 2023, and Why are 7 out of 10 maternal deaths still taking place in Africa? signed by President Ramaphosa and published by Thomson Reuters in May 2023.

2.3 Sexual and reproductive health and rights (SRHR)

PMNCH, through its partners, drives effective evidence-based advocacy to uphold people's rights to essential SRHR services. This is achieved through knowledge generation as well as coordinated and integrated advocacy efforts to strengthen political commitment and policies, and to increase funding for and access to the full spectrum of SRHR interventions, including safe abortion services.

Political advocacy

In 2023, PMNCH held bilateral meetings with heads of government and over 30 ministers at key global and regional policy events such as the World Health Assembly (WHA), G20 Ministerial meetings, Women Deliver and the United Nations General Assembly (UNGA), among others. PMNCH also participated in two Inter-parliamentary Union assemblies, including bilateral meetings with more than 40 national speakers and members of parliament.

Advocacy briefs

In May of 2023, PMNCH facilitated partners' work through the coordination and publication of "Why sexual and reproductive health and rights are essential for Universal Health Coverage". This was used extensively by partners to advocate for strong SRHR and UHC language in the UHC Political Declaration, and a PMNCH consensus statement: "Call to G7 to prioritize SRHR in UHC".

2.4 Political leadership

The Global Leaders Network

PMNCH supported President Ramaphosa in initiating a Global Leaders Network for Women, Children and Adolescents which was announced at the World Economic Forum in January 2023 and was presented by President Ramaphosa at an UNGA side event, "Renewing the Promise for Women, Children and Adolescents", in September 2023, hosted by the Government of South Africa.

The Network will challenge governments to re-imagine global health with women, children and adolescents at the centre and align advocacy to achieve accelerated progress or risk rollbacks across multiple development gains. It is the first and only Southern-led global health diplomacy initiative to support the attainment of the 2030 SDGs related to women, children and adolescents.

At the UNGA side event H.E. Mette Frederiksen, Prime Minister of Denmark and H.E. Saima Wazed, Senior Representative of Bangladesh also spoke. They were joined by Catherine Russell, Executive Director of UNICEF, Senait Fisseha, Director of Global **Programs at the Susan Thompson Buffett Foundation, Winnie Byanyima, Executive Director of UNAIDS, Natalia** Kanem. Executive Director of the UN Population Fund and Hiris Jamal, a UNICEF Youth Advocate, 1.4 million people were reached in social media and media outreach generated a cumulative estimated reach of 290 million.

Lives in the Balance summits – "Protecting the Promise"

Launched in response to COVID-19, the Lives in the Balance summits have grown into an essential venue for learning and collaboration to combat the combined impact of COVID, climate change and growing crises on the most vulnerable. In 2023, for the first time, Lives in the Balance was staged as an in-person event organized by PMNCH on the sidelines of the 2023 World Health Assembly (WHA76). The series of three events was focused on what is needed to "Protect the Promise" for women, children and adolescents in the face of the COVID-19 pandemic, conflict, climate change and rising costs of living. Each event was focused on a particular thematic area of PMNCH:

- The opening event discussed the practical actions countries and partners can take to improve the health and rights of women, children and adolescents;
- Adolescent Well-being and SRHR prioritized adolescent well-being, including comprehensive SRHR programmes and increased momentum for the 1.8 Young People for Change campaign and the GFA; and
- MNCH emphasized the importance of multi-sectoral collaboration in ensuring that every mother, baby and child not only survives, but thrives.

In total in 2023, PMNCH produced nine flagship events and supported 19 partner events of strategic importance. All events provided opportunities to amplify PMNCH's advocacy asks and influence decisions in line with its three thematic priorities. In addition, 190 partner events were amplified on the Events Hub.



The Lives in the Balance event series in 2023 featured 28 speakers with nine ministry and government officials including Dr. Mathume Joseph Phaahla, Minister of Health in South Africa; Dr. Wilhelmina Jallah, Minister of Health in Liberia; Shri Gopalakrishnan, Special Secretary, Ministry of Health and Family Welfare in India; Lorraine Clifford-Lee, Senator and Spokesperson on Health in Ireland; and Xavier Becerra, Secretary of the U.S. Department of Health and Human Services. Social reach surpassed 2.1 million.

2.5 Partner engagement

Digital advocacy hubs

Envisioned as the world's most comprehensive digital advocacy platform for women's, children's and adolescents' health (WCAH), the hubs were launched in 2023 with priority for the GFA, constituencies and country-level hubs to support advocacy and accountability within partner countries. The hubs provide a resource-rich platform for interactive engagement throughout the WCAH community. An Android and iOS app now makes partner collaboration even easier.

Collaborative advocacy action plans (CAAPs)

The initiative centres around more effective and impactful information and engagement among partners in the context of a country, partner-led advocacy plan. They are developed by multiple stakeholders including national governments and PMNCH partners in individual countries across all constituencies. The CAAPs build or strengthen existing platforms where they exist and ensure inclusive and meaningful participation, engagement and decision-making to advance the implementation of national commitments for WCAH by ensuring that existing commitments are followed up and new commitments are mobilized. By the end of 2023, CAAPs were initiated by a broad spectrum of partners in 11 countries including Bangladesh, Ethiopia, Kenya, Liberia, Malawi, Nigeria, Senegal, Sierra Leone, South Africa, Tanzania and Zambia.



A total of 29 hubs were launched in 2023 with 703 active users, 512 posts and 134 app downloads by the end of the year.



2.6 PMNCH media impact

With more partners, new initiatives and a focus on digital innovation, the audience base and reach of PMNCH continued its upward climb in 2023. A year-over-year comparison in Table 1 shows strong gains across all channels.

3. Resource mobilization

- PMNCH raised approximately US\$ 20.7 million for its 2022-23 work, including support for the GFA and the 1.8 Young People for Change campaign.
- The implementation rate against available resources for 2022-23 was 92%.
- PMNCH's donor community continues to grow with contributions in 2022-23 from six government agencies, two philanthropic foundations, one private sector organization and one multilateral organization. The majority of these grants were multi-year in nature, enabling greater sustainability for our work.
- For 2023-24, PMNCH is undertaking intensified engagement with a widening spectrum of potential new donors including national governments, philanthropic foundations and the private sector.
