### Collaboration with H6

### What does the H6 do at the country level

Provide TA to strengthen nat. and sub-nat. capacities for developing, implementing, and monitoring national strategies, plans, and investment cases to improve WCA outcomes in 46 countries.

Facilitates generation of evidence for decision-making and advocacy to support national stakeholders to monitor progress towards the GS and identify implementation bottlenecks and corresponding strategies, incl support to translate evidence into policy and strategies.

Supporting nationally-led efforts to mobilize, coordinate stakeholders including reporting and evaluation behind national SRMNCAH priorities: incountry staff of the H6 facilitates convergence of SRMNCAH global and regional initiatives, such as (among others): EPMM and ENAP; QED Framework; Health Data Collaborative; FP2020, etc.

### PMNCH's complementary role (4A) incl. support of H6

- Promoting/supporting inclusive and meaningful multi-stakeholder engagement
- Catalyze constituency-building and reinforce existing partner networks to strengthen participation of under-represented stakeholder groups in national policy dialogue, planning processes and platforms on women's, children's and adolescent's health (WCAH) and Universal Health Coverage (UHC)
- 3. Strengthening and aligning accountability processes

- 4. Supporting joint advocacy (on SRMNCAH and or 6 EWEC focus areas), as well as on increased financing to SRMNCAH and better use of existing financing
- 5. Facilitating learning and exchange across countries.
- 6. Synthesize, disseminate and advocacy PMNCH guidance briefs and knowledge summaries that provide information on updated evidence and consensus among partners (topics to be identified with H6 and other partners)



### **Collaboration with GFF**

## **GFF** specific functions

Support countries to finance their RMNCAH+N Investment Case priorities; works with partners to create smart, scaled and sustainable funding in-countries through domestic resources, aligned bilateral aid, links with IDA/IBRD and by crowding in private financing; in 27 countries

Support countries to strengthen alignment of financiers/other stakeholders around the RMNCAH+N IC through resource mapping of dev. partners in-country and joint planning for design and implementation of IC and health financing reforms

Develop health financing strategies and identification of health financing reforms to accelerate progress on UHC and set countries on a trajectory towards SDG targets

Support to countries to achieve increased efficiencies for health and nutrition financing; and domestic resource mobilization for health and nutrition (e.g., sin taxes and other types of tax reforms), etc.

### What PMNCH can do to support GFF (4 A's)

# Leverage PMNCH's constituency-based linkages to support efforts in one or more of the 5 key areas:

Working with MOH and MOF, to provide analytical support to develop country-led GFF Investment Case and through support provided to the national multi-stakeholder platform

Broker publicprivate partnerships in the priority countries to strengthen private sector engagement in line with GFF PS engagement strategy.

Working in concerted effort with PMNCH re implementing CSO engagement strategy, and with partners to ensure planning/implementation of learning exchanges among the GFF countries; contribute to GFF country south-to-south learning activities (e.g., monthly webinar series; annual face-to-face GFF country learning events; other)

Working with H6 and other partners at country level to build capacity for development / implementation of GFF ICs


### What PMNCH can do to support GFF (4 A's)


- Support and strengthen national multi-stakeholder platforms that underpin the development and implementation of the GFF Investment Case and health financing strategy, as well as joint advocacy, alignment and monitoring /accountability of results, resources and rights through meaningful participation of all stakeholders
- Support the GFF CSO Engagement Strategy and Implementation Plan, focused at strengthening CSO engagement in achieving GFF objectives, incl. national ICs.

- Support a transparent system for selecting representatives from civil society and private sector, rotation every 2 years through the GFF CSO coordination group
- Through small grants mechanisms support local/national advocacy, alignment and accountability.
- Facilitate / organize learning exchanges among countries in above areas, contribute to EWEC partner learning
